# The University of Texas at Arlington

## The Challenge

With so many states making changes to their immunization laws within the past five years, communicating these changes to students and managing records can be very challenging. For Kelly Singleton of the University of Texas at Arlington, communication to students had been a constant struggle. They would “send numerous communications and have a conference room set up for students to come in and turn in their immunization record.” This method, however, was “problematic as [their] office was already so full with students trying to get admitted or to get their transcript to go elsewhere.” Prior to Magnus, UTA was spending 30-40 hours a week attempting to manage records and to communicate requirements to students and parents.

If a student in TX doesn't provide their immunization record or an affidavit, a hold is placed on the student's account. This has become another big challenge for Texas schools as staff has to not only relay what that means to students, but also to convey what the next steps are to remove this hold. A hold on an account results in a compromised registration process, placing further stress on both the students and the college and university staff.

## The Solution

It takes a lot of time and administrative effort to remain compliant when immunization laws are constantly changing. It is challenging for schools to maintain a certain level of compliance standards, but this task becomes even more difficult when students are so directly involved. 
